Nationality Act)" (resident in United States for at least 5 years, Illinois for at least 6 months, and physically present in United States for at least one-half of that time); or Form N-412, "(Filed under Section 701 of the Nationality Act of 1940)" (no residency requirements, but must state branch of military, date entered, Serial No. entered into military, honorable discharge date, and place of residence at time of enlistment). Volumes 13-22 contains additional information: petitioner's race, last foreign residence, the name under which petitioner entered the United States, date and place of marriage, spouse's date of birth, and date and place entered United States. Volumes 20-22 contains additional information: personal description of the petitioner: sex, color, complexion, color of eyes, color of hair, height in feet and inches, weight in pounds, visible distinctive marks, present nationality, and age; the date and location spouse entered United States, and if naturalized, the date and place naturalization occurred; sex of children; section to list the dates when petitioner was out of the United States for 6 months or longer, must provide date, port, and name of vessel departed and reentered the United States; required petitioner has not been an anarchist, nonbeliever "in the unlawful damage, injury, or destruction of property, or sabotage," disbeliever or opposed to organized government, and member or affiliated with any organization that is opposed to organized government for at least 10 years immediately preceding date of petition. Volume 22 (after September 26, 1951, Petition Number 1614) added to the Oath of Allegiance that petitioner will bear arms, perform noncombatant service in the United States Armed Forces, or perform work of national importance when required by law.

12. **Other Information:** Volume 19 has 5 Form 2234 at the end of volume; Volumes 20 and 21 also contains Form N-415, which is the old Form 2234. Additional documents, including declaration of intent, certificate of arrival, letters from petitioners, witnesses, county clerks, lawyers, and personnel from the United States Department of Labor, Division of Naturalization, and more. The microfilm reels are 30-6224 (contains Volumes 1-3), 30-6225 (contains Volumes 4-6), 30-6234 (contains Volumes 7-8), 30-6235 (contains Volumes 9-10), 30-6236 (contains Volumes 11-13), 30-6237 (contains Volumes 14-18, ending with petitioner number 1385), and 30-6238 (contains Volume 18, starting with petitioner number 1386-Volume 22). Microfilm reels should be used for Volumes 1, 8-10, and 13-22 due to poor condition or extremely tight binding. The exact dates of volumes are hard to determine because the dates listed on the microfilm target sheets vary from volume to volume. Volumes 1-11 and 16 are dated by petition entered in court, and Volumes 12-15 and 17-22 are by date of final judgment.
